Submit Supporting Documents - Travel

Submitting Form DS-260 does not formally execute a visa application. The visa application is not formally made until the visa applicant(s) is interviewed by a U.S. consular officer. After submitting Form DS-260 online, you must print the confirmation page and bring it to your interview.

Online Application - Travel

Some of the supporting documents to be filed with Form DS-260: Confirmation that Form DS-260 had been filled online; Copy of your current passport; Birth certificate (with English translation if necessary); Police clearance certificate if over the age of 16 and lived in the country of application ...

You will not be able to upload any civil documents for a visa applicant until he/she has submitted the immigrant visa application. It will say N/A (not applicable) in the Civil Documents column until the Form DS-260 immigrant visa application is completed on CEAC. If you started uploading documents but did not finish, it will say Incomplete. 1 2

HOW TO UPLOAD DOCUMENTS TO CEAC

Civil documents must bear an original signature, stamp, and seal of the issuing office or registrar. Copies certified by attorneys, Justice of the Peace, Notary Public, etc., are not acceptable. For any document not in English or in the official language of the country from which you are applying, a notarized translation is required in addition ...
