The 2017 federal tax law expanded the Child Tax Credit (CTC) to allow taxpayers to claim up to \$500 as a nonrefundable "Credit for Other Dependents," including elderly parents. Under this provision, in effect through the 2025 tax year, the Internal Revenue Service allows family caregivers to claim some individuals related by adoption, blood or marriage — and even some friends — as ...

Important IRS Tax Tips for Family Caregivers

Family child care providers who are self employed (sole proprietor), or set up as a partnership, Limited Liability Company (LLC) or S Corporation pay business taxes (usually 15.3% Social Security/Medicare taxes) on their profit as well as federal income taxes on the same profit.
