What Are Core Values? Simply put, when a law firm adopts a written statement of core values, the partners are agreeing to promote, embody and be bound by a set of standards that define what it means to be a partner (or lawyer, or employee) in that firm. The standards generally fall into three categories:

Some use-values require no effort to attain: air, sun, gravity, etc. Others require effort to attain. There is a finite limit to the amount of labor that can be devoted to the production of use-values. Society must apportion this labor between the production of different use-values in some way.
